1 What were your main expectations for this meeting? Were they fulfilled?

The EU student boards have a lot of obligations towards their colleagues, professors and their faculties since they take part in decisions on many important things like student fees, student exchange programs, exam organization, voluntary associations, creating various financial funds for helping those students who are not able to pay their own tuition fees. These student boards really protect the interests of students, professors and faculties so their roal is very important in improving the quality of higher education, which should be organized in a perfect way.
13.	Each country has its own model how the student organization is functioning. The presentation from the German student made a special impression on me because it put emphasis on the basic student needs (accommodation, food, transport, culture and help in managing certain procedures and in studying). Declaratively, our student organizations are not much different form the organizations abroad. I do not know if the foreign student organizations manage to realize all the stated activities, but comparing them to the way our organizations function, my opinion is that our organizations do not deal much with the basic needs of students. Instead of it, they deal with high politics.

4.	Presentation about writing scientific papers was surely the best one during the entire meeting. Problems were presented in an effective way and the lecture of the presenter was effective as well. I think that there were too many unnecessary details concerning the presentation about the teaching methodology which distracted the attention of the listeners. The presentation had to be shorter with clearly defined problems and solutions. However, the way in which the material was presented was excellent. Presentation about launching a journal was great as was the way of presenting. Practical training presentation from the colleague from uprija was well done and well given. However, concerning the presentation from Vranje about practical training, I think that the presentation was well done but
	that it was better that it had been given in Serbian.
5.	Each of these presentations was developed to inform the gathering about the things that other institutions do not do a priori and I think that in this sense the presentations were very successful. All the presentations, in general, had the problem with time, which affected the attention of the listeners to a certain extent. That way information is lost.
6.	This was very useful. I have not had the opportunity to hear
.	sistematized presentations related to these topics so far. Some similar presentations of similar topics would be very interesting for the following meeting in Pirot.
7.	I want to congratulate all the authors who made a lot of effort in their presentations. As a graduate lawyer I am pleasently surprised by the presentation on writing scientific papers which was comprehensive and studious. The way of presenting was also very interesting and it drew my attention although I do not write scientific papers. Teaching methodology or methodics which the engineers did not have during their studies nor did they have as a precondition for teaching work, has always been neglected. I hope that the presentation had an influence on them and that they should start paying attention to it in the future. It was good to hear the presentation but maybe on some other occasion since it is not related to the Academy establishing. In my opinion, the presentation on this topic was suggestive, confident and interesting, and it was possible to learn something from it.
8.	I am very satisfied with the presentation of the professor from Niš who explained to us many things which were not clear.
9.	The participants made a lot of effort to inform the listeners about writing scinetific papers, launching journals, practical training and methodology in teaching at the institutions of higher education in the Republic of Serbia.
10.	Presentations were excellent. The presenters gave some practical examples through their presentations.
11./12.	The work on writing scientific papers, launching a journal, teaching methodology and practical training seems to be challenging, confusing, complex, but is most of all useful and didactic. The way of creating one scientific paper was well presented and explained.

13.	Presentations about writing scientific papers and launching a journal were short, clear, interesting and without too many details, so my attention was on a high level. In Serbia there is a problem to organize practical training for careers in production since there is a small number of firms that actually produce something. Another story is whether the students will be able to see something in these firms and apply the theoretical knowledge that they have gained. All praise to the organizers of practical training who have to struggle to keep the practice alive, which cannot be done without.

4. What did you learn? Which part did you or didn't you enjoy?

1.	I have learned a lot by hearing and seeing student colleagues from Germany and Belgium and hearing the presentation from Portugal. I have learned how their student parliaments function, we have exchanged our experiences and I have accepted some of their ways in order to make amendments to the current Student parliament statute. I have also improved my knowledge of English a little bit and now I feel more secure in communication with foreigners.
2.	Topics about quality management were very useful as well as work in the work groups (determining strategic goals and action plans). Maybe the presentations should be written in English for foreign partenrs and presented in Serbian, to avoid translation which slows down the working dynamics. Also, some presentations were very long.

3.	I was made aware of new ideas and possibilities in the development of the student parliament. The work shops are always the most interesting part of the meeting
4.	Many things were not clear to me about writing scientific papers but after the presentation everything is much more clear. This was also the part of the meeting which I liked most. Moreover, I learned a lot by working in a work group, as well as by listening about quality management at IPP and KaHo university.
	I did not like parts of the meeting during which presentations were given in a very bad English. I think that it was better that they were given in Serbian.
5.	I got very important information about the quality control which I expected before the beginning of the meeting. There is no reason that I did not like any part of the meeting.
6.	There is a mechanism in Belgium which checks the quality of students' knowledge apart from the regular examinations. It is a pity that we do not have that kind of mechanism.
7.	The meeting was well organized in general and the organizers should be congratulated on it. I learned that we should fight for our own destiny and that the help aside is just of declarative nature. Money will be given if the results are achieved. There would not be any of it as there would be no Academy if we do not start solving crucial problems.

1. Our future activities: better organization of the team responsible for the project implementation, task delegation, intensifying the activities with the student parliament as
